INTRODUCTION:

The Northern Arizona VA Medical Center (NAVAHCS) is located in Prescott, Arizona and has five Community Based Outpatient Clinics serving Anthem, Flagstaff, Kingman Cottonwood, and Lake Havasu City.

NAVAHCS proudly serves over 29,000 Veterans across 65,000 beautiful square miles of northern Arizona. We are a complexity level three facility, which houses 85 bed CLC, 15 bed Acute Care Unit, 120 bed Domiciliary, and a 24/7 Emergency Department.
