The Training Sites

The VA Greater Los Angeles Healthcare System (VAGLAHS) is one of the largest health care facilities within the Department of Veterans Affairs. It is one component of the VA Desert Pacific Healthcare Network (VISN22) offering services to Veterans residing in Southern California and Southern Nevada. VAGLAHS consists of two ambulatory care centers, a tertiary care facility and 8 community-based outpatient clinics. VAGLAHS serves Veterans residing throughout five counties: Los Angeles, Ventura, Kern, Santa Barbara, and San Luis Obispo. There are 1.4 million Veterans in the VAGLAHS service area. The VAGLAHS directs the Department of Veterans Affairs' largest educational enterprise.

We serve as a major training site for medical residencies sponsored by the <u>UCLA David Geffen School of Medicine</u> and <u>USC School of Medicine</u>, as well as more than 45 colleges, universities and vocational schools in 17 different medical, nursing, paramedical and administrative programs. Over 500 University residents, interns, and students are trained at the VA Greater Los Angeles Healthcare System each year. The institution sponsors 16 medical residencies and numerous associated health residencies and internships in dentistry, podiatry, optometry, pharmacy, clinical psychology, social work and dietetics.

VAGLAHS prides itself in its diversity, equity and inclusion where the strategic objective is to recruit, hire, train, develop, and retain a diverse workforce to allow all individuals to realize their full potential and to meet current and future needs and challenges for Veterans and their families.



The West Los Angeles (WLA) Medical Center is a tertiary care teaching facility dedicated to providing a wide array of acute and ambulatory patient care services to our nation's veterans. The comprehensive diagnostic and treatment services provided include a broad range of medical, surgical, and psychiatric care. Internal medicine subspecialties include cardiology, infectious diseases, gastroenterology, allergy, pulmonology, nephrology, endocrinology, rheumatology, and hematology/oncology. Major surgical subspecialties include orthopedics, urology, neurosurgery, ophthalmology, plastics, ENT, podiatry, and cardiothoracic surgery. In addition to the main acute care hospital, there is a 180-bed nursing home, a hospice unit, and Home-Based Primary Care.

The Sepulveda Ambulatory Care Center (SACC; SEP) offers a state-of-the-art ambulatory care facility. The center has specialty outpatient programs in spinal cord injury, stroke rehabilitation, women's health, preventative medicine, dentistry, and mental health, and chemical dependency. Extended care activities include a 120-bed Academic Nursing Home and a Home-Based Primary Care Program. The facility hosts extensive clinical and basic science research, including Geriatric Research Education and Clinical Center (GRECC) and Field Program for Health Science Research and Development (HSR&D). The HSR&D program



evaluates provider practice and patient outcome studies in the delivery of ambulatory health care.





The Los Angeles Ambulatory Care Center (LAACC; LAO) is located in the heart of Downtown Los Angeles. It serves as a centrally located facility for the diverse veteran population of the city of Los Angeles, focusing on primary care and mental health services. The clinic provides special services in post-traumatic stress disorder, day treatment, medical service, and mental health services.

General Program Information

The PGY1 Pharmacy Residency conducted by VA Greater Los Angeles Healthcare System (VAGLAHS) in Los Angeles, California is accredited by ASHP. We were first established in 1952 and are considered one of the first postgraduate pharmacy programs in the nation. In 1963, it was one of the first pharmacy residency programs accredited by ASHP. It is a twelve-month long program that offers a diverse hospital-based residency experience with emphasis on clinical pharmacy activities. This residency is structured to offer the resident a well-rounded clinical experience in acute care, ambulatory care, and pharmacy administration.

The VAGLAHS also offers PGY2 specialty residency programs in the area of Ambulatory Care and Neurology. The PGY2 programs allow for Early Commitment to our current PGY1 residents. Our PGY2 Neurology Program also offers VA National Early Commitment to all PGY1 VA pharmacy residents. Please refer to the PGY2 Program Booklet for more information regarding our PGY2 programs.

Pharmacists completing this residency will be competent and confident practitioners in multiple

patient-care environments. They will demonstrate competence by appropriately utilizing their clinical knowledge and skills, with the ultimate goal of possessing the ability to apply these skills to a variety of situations. They will develop confidence through the feedback and independence offered to them through each of their experiences. These pharmacists will be accountable for achieving optimal drug therapy outcomes as members of the healthcare team. They will also refine their skills in educating other healthcare professionals and patients on drug-related topics.

VAGLAHS has established academic affiliations with local schools of pharmacy including USC, UCSF, UCSD, UOP, Western University, and Loma Linda University. Residents have ongoing teaching responsibilities to pharmacy students and other trainees, as well as hospital staff. VAGLAHS is affiliated with the USC Alfred E. Mann School of Pharmacy and Pharmaceutical Sciences and offers residents the option of a teaching certificate and appointment as Adjunct Clinical Instructor of Pharmacy Practice at USC Mann.



Program Structure

The Primary Practice Site is located at West Los Angeles (WLA) campus. Other potential learning experience locations that may require traveling to the site include Sepulveda (SEP), downtown Los Angeles (LAO), and USC Alfred E. Mann School of Pharmacy and Pharmaceutical Sciences.

The Primary Practice Site is used for a minimum of 60% of the training for all residents in the program. No other practice site is used for more than 25% of any resident's training.

Per ASHP Standards, at least half of the residency year is in a required learning experience. Two-thirds or more of the program is required to be in patient care activities, and no more than one-third of direct patient care learning experiences may focus on a specific disease state or population (ie. critical care).

ORIENTATION

VAGLAHS PGY1 Pharmacy Residents are required to successfully complete Orientation at the start of the residency year at the Primary Practice Site. Orientation length is ~2 weeks long.

BLOCK ROTATIONS

VAGLAHS PGY1 Pharmacy Residents are required to successfully complete **8 block rotations**. Block rotation lengths are 5 to 7 weeks long depending on the time of year it is scheduled. Rotations are located at the Primary Practice Site unless otherwise noted.

- **2. PBM** (Pharmacy Benefits Management)

LONGITUDINAL EXPERIENCES

VAGLAHS PGY1 Pharmacy Residents are required to complete **3 longitudinal experiences** located at the Primary Practice Site.

Residents also have the option to take an elective longitudinal experience located at USC Mann.

REQUIRED (12-months long)

1. Education/Teaching

For this required longitudinal experience, residents are required to be primary preceptor for 1 IPPE pharmacy student (Level I/II/III). Residents will also be required to develop a formal Noon Conference presentation which will be presented to all pharmacy staff and/or internal medicine residents/medical students. Residents will also have the opportunity to precept APPE pharmacy students (Level IV) and will be taught and evaluated during various block rotation.

2. QI/Research Project

VAGLAHS utilizes the Flipped or Inverted Research Model (IRM) for residency projects. Residents work on 2 projects throughout the year: 1) Project #1 – Complete a pre-existing project started by a previous resident; 2) Project #2 (Flipped Model) – Initiate a new project to be completed by a following resident. Dedicated QI/Research Project Time occur a ½ Thursday once a month, plus during Winter QI/Research Week, and Spring QI/Research Week.

3. Staffing

Residents are required to function as a pharmacist in the inpatient setting for average 1 day every 2 weekends throughout the year starting quarter 2, as well as at least 2 days in the outpatient setting (total 18 weekend days). Inpatient staffing covers IV room, ICU, ward, VA community living center (CLC), and ED patients, in addition to patients on PK and heparin per pharmacy medications. Additional outpatient staffing experience is integrated into ambulatory care rotation(s), where the residents will assist in reviewing and processing computerized prescriptions and dispensing/operations.

ELECTIVE (10-months long)

• USC Teaching Certificate Program

Residents have the option of a joint academic appointment with the USC Alfred E. Mann School of Pharmacy which includes a USC faculty appointment and earning a teaching certificate. Responsibilities include teaching/facilitating discussions for Level I, II and III pharmacy students, as well as providing lecture(s) to Pharm.D. students and/or undergraduate pre-pharmacy students. Residents are provided the opportunity to participate in various scheduled coursework and seminars developed to enhance the residency experience. Leadership opportunities are available. This is a 10-month long longitudinal experience that occurs ½ day every Thursday.



AREA OF FOCUS (optional)

VAGLAHS provides unique opportunities for our PGY1 Pharmacy Residents to have an optional Area of Focus that provides focused experiences in the resident's practice areas of interest. The optional Area of Focus is accomplished by taking 2 electives in the specialty area, which can be fulfilled by the following:

 - 2. ED
 - 3. MICU
 - 4. SICU/TPN
- 1 elective must be in the following:
 - 1. ED
 - 2. Geriatrics Acute Care/AmCare 1

Note, cannot exceed total 2 rotations in Critical Care (ie. CCU, MICU, and/or SICU/TPN). In addition, rotations listed can only be taken once during the residency year.

Acute Care Rotations

The VA Greater Los Angeles Healthcare System (VAGLAHS) offers a distinctive experience in the area of acute care. All acute care rotations take place at the West Los Angeles (WLA) campus.

Preceptors involved with each rotation are specialty trained, many having completed post-doctorate residencies and obtained board certification in pharmacotherapy.

In these rotations, residents will work closely with clinical pharmacists. Residents will also round with providers and ancillary services as an active member of the healthcare team. Residents will regularly review medication profiles for appropriateness of therapy, evaluate laboratory tests as they relate to drug therapy, obtain complete medication histories to detect adverse drug events, drug interactions,

allergies, and other untoward drug related effects, recommend alternatives to prescribed drug regimens when appropriate with an expected endpoint of achieving optimal pharmacotherapy, and provide drug information services and patient education.

As pertinent to each rotation, residents will have opportunities to perform pharmacokinetic dosing and heparin monitoring, BLS/ACLS, review ICU sedation and paralytic protocols, monitor pressors, initiate/adjust TPN, perform medication reconciliation on admission and discharge, and provide patient counseling.

A focused area of study in acute care is available for residents interested in receiving additional training in this specialty.

Ambulatory Care Rotations

The VA Greater Los Angeles Healthcare System (VAGLAHS) offers a distinctive experience in the area of ambulatory care. The Primary Practice Site is located at West Los Angeles (WLA) campus. Other potential locations include Sepulveda (SEP), downtown Los Angeles (LAO), or virtual/remote.

Preceptors involved are specialty trained, many having completed post-doctorate residencies and obtained advanced certifications.

In these rotations, residents will work with clinical pharmacy specialists in our primary care or subspecialty clinics, participating as integral members of an interdisciplinary team. Residents will regularly review medication profiles for appropriateness of therapy, evaluate laboratory tests as they relate to drug therapy, obtain complete medication histories to detect adverse drug events, drug interactions, allergies, and other untoward drug related effects,

recommend alternatives to prescribed drug regimens when appropriate with an expected endpoint of achieving optimal therapy, provide drug information services, and provide patient education.

Residents have opportunities to provide care through innovative modalities, such as Clinical Video Telehealth (CVT), Shared Medical Appointment (SMAs), and VA Video Connect (VVC). Various opportunities to provide patient and staff education exists at all practice areas.

A focused area of study in ambulatory care is available for residents interested in receiving additional training in this specialty.



Mentorship Program

At VAGLAHS, we provide a Mentorship Program that serves as additional support and guidance for our PGY1 residents throughout their residency year. Mentors are current pharmacist staff at VAGLAHS, who provide residents with support that goes beyond the RPD and learning experience preceptors. The program gives opportunity for residents to build a relationship and connection with a pharmacist at VAGLAHS, and learn from their experiences. Other benefits of the Mentorship Program include increase self-awareness, self-reflection, and self-confidence, improves goal-setting skills, exposes resident to new and different perspectives, and grows a personal network.

Leadership Positions

There are various leadership opportunities available for interested residents, both at VAGLAHS and at USC Mann for those who opt into the USC Teaching Certificate Program. Leadership positions provide residents with opportunity to develop their leadership, communication, teamwork, and time-management skills. Available leadership positions include the following:

How is a resident's rotation schedule determined?

Resident's individual rotation schedule is specifically built based on the resident's expressed interests coming into the residency year, such as selection of an optional Area of Focus, interest in pursuing a PGY2, pharmacy areas of interests, and list of top rotations of interest.

Is there flexibility for residents to change their rotation schedule later if their interests or goals change?

Yes! The RPD actively works hard to ensure residents' rotation schedule aligns with the resident's current interests and goals. The RPD works with the resident one-on-one to update the rotation schedule if needed to align with any new interests and goals.
