

# PGY2 GERIATRIC PHARMACY RESIDENCY PROGRAM

## VA Eastern Colorado Health Care System (VA ECHCS)

Aurora, Colorado

The PGY2 Geriatric Pharmacy Residency is a 12-month program that will provide robust clinical training in a variety of settings. The resident will take advantage of the training and educational opportunities available through the University of Colorado School of Medicine Geriatric Fellowship and the Geriatric Research Education and Clinical Center (GRECC) training programs. Most rotations will be completed at the Rocky Mountain Regional VA Medical Center and the State Veterans Home (SVH), located on the same campus, and elective experiences are also available at the University of Colorado Hospital (UCH).

The new Rocky Mountain Regional (RMR) VA Medical Center provides a full-range of state-of-the-art patient care services. RMR is a 182-bed hospital with a 30-bed spinal-cord injury treatment center. Healthcare services are also provided at geographically dispersed locations throughout eastern Colorado including community-based outpatient clinics, primary care telehealth, PTSD rehabilitation, and homeless veteran's domiciliary. RMR employs over 3,000 personnel in 150 occupations.

Applicants must also be enrolled in or have completed PGY1 training. Applicant must be a licensed pharmacist in any state. Residents will be expected to be licensed in Colorado within 90 days of starting the program. Interviews will be scheduled after evaluation of the application.
