VA Maine Healthcare System is comprised of Togus Medical Center in Augusta, 8 Community Based Outpatient Clinics (CBOCs) and 3 Access Point Clinics located throughout the state.

Of the nearly 40,000 veterans served by VA Maine, 82% are classified rural or highly rural.



The Bangor CBOC serves over 7,000 Veterans and offers a wide range of services including primary care, mental health, cardiology, dermatology, dental, optometry, audiology, lab, radiology, physical therapy, and clinical pharmacy. Bangor clinical pharmacists are integrated members of the Patient Aligned Care Team (PACT) and provide services to the Bangor and Lincoln CBOCs.

Bangor is located in central Maine, about 1.5 hours from Augusta and 2 hours from Portland. Downtown Bangor offers diverse restaurants, bars, and shopping. Residency Description

The PGY2 resident will longitudinally manage complex patients within a rural ambulatory practice. The resident will be integrated into the PACT team and provide clinical pharmacy services in-clinic and remotely utilizing telephone and video telehealth. The primary clinical site is Bangor; however, the resident may complete elective rotations at the Togus Medical Center or other CBOC.

- U.S. Citizenship required
- Completion of an ASHP accredited PGY1 Pharmacy Residency
- Eligible for pharmacist licensure in any state
