RESIDENCY EXPERIENCE

Our PGY1 residency integrates acute and ambulatory care, drug information and practice management. It is tailored to each resident to provide the basic foundation for the highest level of clinical pharmacy practice. Under the guidance of VA clinical faculty, residents gain invaluable experience in internal medicine, geriatrics, infectious disease, critical care, hematology/oncology, anticoagulation, drug information, administration, ambulatory care, transplant, surgery, pharmacoeconomics, drug use evaluation, experiential education, and pharmacy and therapeutics committee functions.

Residents participate in journal club, prepare pharmacy newsletters and present staff and patient education. Core rotations are five weeks. Elective rotations are four weeks long.

Qualified applicants are:

- U.S. citizens.
- Graduates or eligible for graduation from an **Accreditation Council for** Pharmacy (ACPE)-accredited college of pharmacy.
- Licensed or eligible for licensure as a pharmacist in any state.
- Bound by the rules of the **Resident Matching** Program (RMP) process.
- Registered to apply through PhORCAS.
- Open to participating in an on-site or virtual interview.

- Curriculum vitae
- Pharmacy college transcripts
- Three letters of recommendation

Applicants who will not be interviewed will be notified by March 1.
