PGY2 Internal Medicine Pharmacy Residency



Our Program

PGY2 residency programs build upon Doctor of Pharmacy (PharmD) education and PGY1 pharmacy residency training to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives for advanced practice areas. Residents who successfully complete PGY2 residency programs are prepared for advanced patient care or other specialized positions, and board certification in the advanced practice area, if available.

The South Texas Veterans Health Care System (STVHCS) PGY2 Internal Medicine Pharmacy Residency was initially accredited by ASHP in 2014 and is designed to provide a challenging training opportunity for individuals desiring to develop clinical competency in the area of Internal Medicine. The 12-month training period incorporates a heavy emphasis on inpatient acute care rotations with a longitudinal ambulatory care rotation, enabling graduates of the program to be competent in both inpatient and outpatient practice settings.

This residency allows for ample teaching opportunities, both didactic and preceptorship, as well as a formal teaching certificate program. At the completion of this year-long training program, the resident is qualified for positions in clinical pharmacy and academia as clinical faculty. This program was started in 2012, and has a history of many successful graduates who have accepted clinical pharmacy specialist positions at both VA and non-VA hospitals in a variety of specialties, including Internal Medicine, Antimicrobial Stewardship, Surgery, Emergency Medicine, Cardiology, Infectious Diseases, Nephrology, Neurology, Ambulatory Care, Academic Detailing, and university faculty.

 - Research/Practice Management - longitudinal with focused research month
 - Geriatric Ambulatory Care - longitudinal clinic
 - Staffing: inpatient pharmacy/IV room, discharge counseling, on-call service
