The purpose of the PGY1 Residency Program is to build on Doctor of Pharmacy (PharmD) education and outcomes to contribute to the development of clinical pharmacists responsible for medication-related care of patients, eligible for board certification, and eligible for postgraduate year two (PGY2) pharmacy residency training.

We provide opportunities for the Resident to enhance his/her knowledge, skills, and abilities to effectively provide pharmaceutical care services in a variety of patient care environments. The Resident will improve his/her communication skills with other healthcare providers and patients, strengthen drug information skills, learn to promote cost effective drug therapy, and nurture a commitment to lifelong learning.

Beckley VA Medical Center is a Joint Commission accredited, complexity level II facility serving Veterans in 11 counties in southern West Virginia. The medical center opened its doors to Veterans on March 1, 1951, and today is a 25-bed general medical/surgical and 5-bed intensive care facility with a 50-bed community living center.

The community living center offers skilled nursing care, post-acute rehabilitation and restorative care, hospice, palliative care, and respite care for eligible Veterans.

- Doctor of Pharmacy Degree (Pharm.D.) from an ACPE-accredited college
